# **C235 MAYOR'S ANNOUNCEMENTS continued**

The Town Manager will read a short statement regarding the accounts.

C Lacey read the following statement:-

It was identified by the Auditor on the Purple Annual Return Form 2016-17 that both income and expenditure has been netted off by journals from reserves. This altered the amount shown in the Income Statement, which is why this did not match the reserves movement on the balance sheet. It would appear as if we were missing £131,401 of expenditure which must be shown as part of box 6 on the Annual Return.

It is purely a clerical error.

The way to correct this was for journals to be posted to the relevant income and expenditure code – reinstating the expenditure with the other side of the entry being posted to general reserves code 310.

Dear Brian

I reviewed the annual return workings on Thursday and Friday last week and reported that there were errors on the accounts – whereby expenditure had been posted in error directly to the reserves accounts instead of the income and expenditure statement. This meant expenditure was seriously understated and carried forward reserves were overstated. This was evidenced by reconciliation to the underlying records. I

reported back to Claire the accounts that were in error and suggested that if these could be investigated and corrected we could be in a position to agree, the annual return could be sent to council for signing off.

Claire engaged RBS to review the accounts again and they have made circa 30 changes to correct the miss-posted items. The annual return was re-written and sent through to me together with supporting documentation on email this morning. I have reviewed the entries on the annual return and can confirm from an accounting perspective:

- · The annual return contains the correct comparatives & bfwd figures
- · The annual return is correctly prepared on the income and expenditure basis
- · The annual return casts correctly
- · The annual return is supported by a bank reconciliation which in turns agrees to the bank statements
- · The box 7 & 8 reconciliation agrees to the annual return and balance sheet.
- · The surplus on the income statement agrees to the annual return
- · The underlying sales ledger and purchase ledger are reconcilable to the balance sheet

On this basis – the council can sign off section 1 the annual governance statement and section 2 the statement of accounts, although as always this remains a council decision.

Signing off section 1 and section 2 of the annual return is not reliant on the internal audit being carried out in advance – I may be coming in on Friday to do some hard copy sampling, from what I can see it is remote that the numbers will change, if anything I may find that systems and process were deficient or unable to fully substantiate the financials presented. This does not mean the financials are incorrect – it will just highlight that evidence to support a robust opinion is insufficient.

Should you require any further explanation – please do not hesitate to contact me

Cllr. R Coles had brought up that previously there were incorrect procedures and that internal control measures were required. The Councillor had attended meetings monthly with the RFO to review spending for the L&A Committee as previous Chair of that Committee.

Cllr. D Neave confirmed that the Chairs of Committees now review the budgets / accounts periodically and thanked the Officers for providing more frequent information.

Cllr. J Farmiloe did not agree for the Annual Return to be signed off and stated that she had been advised they would be responsible if found to be in error.

Cllr. B Gosling informed the Council that he had contacted the External Auditor, Littlejohns.

Cllr. R Robertson asked where the resolution of Council was, or, who had authorised Councillors to contact the External Auditor.

Cllr. R Coles reiterated that it was wrong for Councillors to speak on behalf of the Council as individuals and confirmed that Standing Orders state Councillors must engage with Officers to confirm the correct procedures, Councillors cannot act alone, nor without a Council Resolution and that they should not be contacting the Auditor.
