## LA120 W RITTEN RESPONSES TO PUBLIC QUESTIONS continued

Questior Who is responsible for Centenary Park? Is the Big Park Project Board still running?

Minutes from previous meeting at which the Maintenance schedule and handover agreement was presented to Council 19/07/16.

The Big Park/Centenary Park land is owned by Lewes District Council. The land is likely to always be owned by them an d PTC has approximately 998 years remaining on a lease.

The Big  $m{P}$ ark Project was managed by the Project Manager at Lewes District Council, Chris Bib.

The projects were implemented and subsequently fell under a 1 year maintenance term (snagging).

This completed and part of the park (play equipment and toilets etc) were handed over to Peacehaven Town Council Grounds team in May 2016.

Due to further projects coming to the park, the Project Manager and the Big Park Project board is still in existence and will remain, until their next meeting, where future projects will be discussed. This is yet to be confirmed as November 2016.

Terms of reference will be reviewed, as will the future of the project board.

As stated at a previous Committee, once the archaeology / hut site is begun at the Big Park, the Big Park Project Board will consist of minimum 3 Councillors for the Town Council and an Officer of the Council. It is possible that Councillors will rotate on that committee, but PTC will always retain a presence and voting rights.

The Park was officially named by the Duke of Gloucester in April 2015 and opened to residents to use from that date.
