# Grounds Team Premises - Centenary Park

Today we received the following response from the Planning Office at Lewes District Council with regards to our planning enquiry stating:-

'A building of this size is considered to be excessive in relation to the required use. You are advised to consider a smaller building that would have less visual impact on the surrounding area. We are happy to advise further on suitable alternative buildings, but to do this we will require photos of the proposed building and a map marking exactly where the building would be positioned. We would then be able to provide a more detailed response on the proposal.'

This response has only just been received and we will be seeking further advice from Lewes District Council.

It should be noted that the premises currently occupied by the Grounds Team is unsuitable.

Although the Council has been receiving Section 106 monies for some years there seems to be some confusion how this works.

# **LA101 PUBLIC QUESTIONS continued**

Section 106 requires large developments to pay monies for related infrastructure work which under S106 is paid on completion of the works.

In order for Peacehaven Council to forward plan, Lewes District Council (LDC) provide on a regular basis a list of such sites, monies and the date at which the payment will be available.

This enables the Council to agree with LDC what the monies will be spent on which is a statutory requirement, for example there is a need for a children's play park at the extreme east end of Peacehaven where three of the developments are taking place.

If this is not provided then either the Town Manager or one of the six Peacehaven District Councillors should be chasing, not via a solicitor which will only alienate LDC Officers and also unnecessarily spend Council money which currently appears to be heavily in the red.

This applies up to the 31st March 2016, from the 1st April 2016 the Community Infrastructure Levy (CIL) applies whereby the developer is required to pay the monies up front. Therefore it is even more important for the Council to identify the sum and agree allocation soonest.

I repeat you do not need a solicitor to process this.'

Cllr. R Coles requested that the resident did not read a prepared statement and asked what question was being raised

The resident responded noting the Council's confusion with regards to Section 106 monies and enquired what action Peacehaven Town Council (PTC) was taking and continued with the following:-

'Agenda item 9, Dogs and Park Bye Laws.

Whilst this is an excellent set of legislation, schedule's 1 and 2 only list three sites in Peacehaven:-

- Cinque Foil
- Downland Avenue
- Meridian Park

If you wish to adopt this byelaw you are required to identify and add all the locations to the schedule, it should be signed by the Secretary of State for Environment or similar, otherwise the byelaw cannot be enforced.'

Cllr. R Maskell stated that Andy Frost from LDC is working on Section 106 allocation details

# John Carden - East Ward

The resident noted that at a previous meeting, painting the Peacehaven pillars had been discussed and stated this work had been completed once scaffolding had been installed. The resident queried the subsequent work whereby the finial and border was painted gold and questioned how this had been completed and if scaffolding had been re-installed noting that it was illegal without this type of equipment
