## Alan Sargent - West Ward (Chair of Residents Association)

The resident read the following:-

## Agenda Item 10 - Eco Toilet

I refer to the minutes dated 5<sup>th</sup> September 2017 attached to your agenda, pages 1 and 2 under the title vandalism and then refer to Agenda Item 10 – Eco Toilet.

Why is the Council proposing to spend between £750 and £1,295 on a single cubicle toilet manufactured from timber and installed in an isolated location such as The Oval?

The minutes of the 5<sup>th</sup> September report the seriousness of vandalism that is prevailing within Peacehaven and yet the Council is offering an ideal target. Within the proposal tabled there is no risk assessment or evidence that the Environmental or Planning Officers have been consulted.

If you decide to proceed at least purchase a metal one and paint it to blend in to the surrounding area.

C McBryer informed the resident that a risk assessment had been completed with regards to the eco toilet and that the Council is working with Sussex Police to reduce vandalism

# LA181 Public Questions (page 4)

I refer to the comment "Mr Sargent continued at some length on this matter", at the time I did not exceed the three minutes allocated and this comment as a minute is totally invalid. What has not been included is the statement I read out which the Clerk had a copy of explaining clearly the reasons for the limit of confidential business.

By law minutes of Council and Committee meetings are required to be accurate and factual, as a legal document it can be used in evidence and they are required to be kept archived forever. I strongly request that the statement that was omitted in included in the minutes of this meeting otherwise the public might interpret that the Council is suppressing information. I also request that the Council verifies the statement in writing with Ian Davison at Hedleys Solicitors LLP who carries out Council legal training and provides advice.

In addition I do not recall Mr. McBryer making the detailed statement in the last paragraph of the subject in the minutes but I could be wrong. Would the Chair kindly verify this by reviewing the recording now being made of each meeting?

C McBryer informed the resident that at the meeting on 5<sup>th</sup> September he had exceeded the three minutes allocated to each resident and that the Council are abiding by legal requirements

The peddle bike also requires attention as does the matting on the ground as this is a problem when the ground is very wet.

The resident informed Members that a personal trainer (as proposed on Agenda Item 9) is not necessary until early spring 2018.

C McBryer agreed some of the equipment in the outdoor gym is of poor quality however it is checked regularly and confirmed the new equipment meets Health and Safety regulations. C McBryer confirmed it was not viable to repair the cross trainer and there would be a cost issue replacing the matting however it is not unsafe and bark could be used to improve the ground

Cllr. D Neave requested the feasibility of replacing peddle bike be investigated

Cllr. R Coles questioned the excessive cost of installing new gym equipment

C McBryer confirmed the installation cost was the standard rate and that Council had been fortunate previously when equipment had been installed free of charge however this had taken some time to be actioned
