SARAH CAULFIELD, EAST WARD

I have been asked by some of the residents of Cissbury Avenue and Downland Avenue, Peacehaven to put forward the following questions-

Regarding the proposal to run a full bus service along the route of Arundel Road, Cissbury Avenue, Downland Avenue and onto the South Coast Road

- 1. Having lived on Cissbury Avenue for over 14 years I cannot see how a full sized bus will access the turning off of Arundel Road into Cissbury Avenue due to the angle of the turning also that residents cars are parked along this road as there is not sufficient off road/driveway parking to accommodate cars. Downland Avenue has even more limited off road parking so this would be even harder to negotiate a bus along this route safely. The roads (Cissbury Avenue and Downland Avenue) are too narrow to accommodate a bus route.
- 2. There are green areas in the Downland Avenue and Ashington Gardens areas where children can freely play this would be too dangerous to continue if a bus was routed along this route. These areas were given to the residents when the houses were built over 50 years ago.
- 3. If this route is supposed to give access to the new housing development how does going via East Peacehaven benefit the residents?
- 4. There is a retirement home on the corner of Roundhay Avenue/Cissbury Avenue where visitors including medical care visit and park in the area where will these cars park if this bus service goes ahead as I am sure there will be more parking restrictions.
- 5. With the current traffic calming on the Arundel Road how will buses and other cars use this road as it is hard enough to do so at present.
- 6. The junction from Downland Avenue onto the South Coast Road is a very dangerous junction and in a car proves very hard to exit how will a full size bus turn left into Newhaven as it will have to go over the oncoming lane to be able to do so.
- 7. A resident of 1B Arundel Road would specifically like his thoughts noted too as he is disabled and has to park his car in Cissbury Avenue due to restrictions on Arundel Road, he is also concerned regarding pollution from this bus route and pollution to the Downland Court residents also how the bus would negotiate its way down the route without causing damage to other cars.
- 8. Homeowners are worried this bus route would devalue their property 9. The residents would not object to a small mini bus service to serve this area but not a full size bus either single or double decker bus.

10. Privacy to houses on the route.11. All residents of the Downland estate/East Peacehaven have been served by the South Coast Road bus service for over 50 years and with obesity being at it's highest rate we should surely being encouraging people to walk to a bus stop not expect a bus to come to you - disabled people can access the County Rider or CTLA service.

This is a small snapshot of some of the questions the residents would like answered and some other residents might attend the meeting independently.

MIKE GATTI, PEACEHAVEN FOCUS GROUP

Living as I do opposite a school. I witness parents dropping off and picking up their children most days. Parents regularly park as close to the entrance as possible, especially at picking up time. This means unfortunately that parents arriving by car are getting their earlier and earlier to secure a prime spot, sometimes 45 minutes or more before the children leave. In winter, this means that many drivers keep their engines running in order to keep warm, and in summer keep the air con on to keep cool. This so near a school entrance cannot be good for the environment, or the health of the children. Would it be possible to have signs installed, similar to the ones in the photo below from Lewes, adjacent to schools to encourage drivers to switch off their engines while they wait to pick up their children? I feel that this would benefit the children's health, and in a small way help the environment by reducing pollution; it may also help educate the children as to the need for curbing harmful emissions. As you may be aware the developers at Lower Hoddern Farm are to begin work to create the new entrance for the site on Pelham Rise on the 22nd October.

If I remember correctly residents were assured originally, that construction traffic would not use this entrance, but would use the one at Hoyle Road.

Can this be confirmed with the developers?

Regarding the sign installed on Pelham Rise advertising the new estate.

Is this within the site boundary or not? As it is difficult to be certain from the plans on-line. Can this be confirmed?

Does it have, or require permission to be erected? As I was under the impression that signs had to be approved by Council.

LUCY SYMONDS

Please could the Council advise as to what safety measures are being put in place for pedestrians including school children crossing the roads at Pelham Rise to access both the South end of the town and Meridian School now that the plans have been agreed for the new housing estate at Hoddern Farm, I am concerned that the additional construction traffic and the traffic from residents of the estate will increase dramatically. Many commuters, if heading into Brighton, will automatically turn right out of the estate and head around the back of Peacehaven to join the traffic on the A259. More local journeys accessing out of area schools and doctors due to limited spaces in the town will also mean more regular traffic. Already we experience speeding cars travelling both North and South on Pelham Rise, despite dangerous bends and limited visibility. You will note from pictures A,B and C that cars accessing local businesses already restrict a crossing point from the Coney Furlong estate making it difficult for pedestrians (including children) to see if safe to cross. D, E, F, G, I J, K, M, N and O, show the bends at which cars speed excessively plus demonstrating the obstacles to clear

visibility of pedestrians. These include parked cars and low bearing trees. Pictures P, Q and R provide a North and South view of the crossing from Coney Furlong. The bends are short in distance especially when a vehicle is travelling a speed.

Pictures H highights the view where the entrance is going to be for traffic entering and exiting Hoddern Farm which then adjoins pictures S, T and U. You will see from the pictures the road where pedestrians have to risk crossing daily to reach either Meridian School or coming South to the Meridian Centre especially with the bend from Roderick Avenue onto Pelham Rise.

Unapproved Minutes- Previous Minutes from this Committee dated 12th June and 10th July were not submitted to Full Council on the 16th October. They had been deferred from the previous Full Council held on the 20th September because of a number of errors but this did not occur. Councillors should be aware that such Minutes must be signed by the Chair and notified at Full Council is acting "Ultra Vires" above the law. Would the Chair kindly give an explanation to this Meeting for the failure which is at serious concern? Grass Verge Cutting and Maintenance budget responsibility for this actions falls under this Committee. What forward thinking by this Committee is taking place to overcome the Council having to pay for this service in 2019/2020 dumping the problem into next year's precept will not resolve the problem and create double taxation.
