### GROUNDSTAFF UPDATE

- The groundstaff have been busy renovating all the towns' football pitches carrying out aeration, scarification and over seeding.
- We have also removed a fallen tree from the Bovis homes site, this was dealt with on a Saturday morning, so the pathways were kept clear and safe, we checked the trees nearby and found another tree with significant rot, so we removed this as well.
- Currently we are pruning the trees surrounding the football club to bring them back in to shape, as well as mowing all the parks etc. There have also been several break downs of our old ride on mowers which have hindered our works.
- Andy Pickton has refurbished several benches in Epinay park and the Oval replacing broken slats and rotten timbers as well as fence repairs at the Oval.

The following document shows what the cycle hub plans are, they have permission for a second clad container and are planning to fit a shelter between the two containers, they have been informed that they may need planning permission if they are setting the structure in the ground. Sustrans have also indicated they would like to connect to the electricity and we are waiting for a document showing how they intend to do this.

Peacehaven Cycle and Walking Hub

### Location

The Hub is located in The Centenary Park in Peacehaven, otherwise known as The Big Park. The Hub currently consists of one 20ft shipping container that is situated on the patch of grass directly next to the Café. The container is clad in Sweet Chestnut weather boarding and therefore has an attractive appearance that blends in with the look and feel of the café building.

### Purpose

The Peacehaven Cycling and Walking Hub has been established as part of the Active Access for Growth project with funding from East Sussex County Council and Sustrans as the delivery partner. In March 2019 Sustrans appointed Jamie Lloyd to act as a Cycle Hub officer to oversee the further development and growth of the hub as an activity centre.

The Hub's aims are to provide the tools and facilities for local user groups to engage in walking and cycling activities with little or no cost to them. The hub therefore contains two sets of professional bike tools and a selection of Electric Mountain Bikes and regular bikes that are available for use by any community group or project that wish to use them. The aim also aims to act as a signposting and information resource for anyone looking to walk or cycle in the local area and beyond

The primary user group that uses the hub tools and facilities regularly are Cycle Seahaven who are a large cycling group with over 350 members with a balanced mix of ages and gender. Cycle Seahaven hold monthly 'Dr Bike' sessions where anyone can bring along their bike to the hub to have it serviced and repaired. They also run regular bike trips from the hub which are aimed at a range of users from the very experienced to newcomers and beginners. Due to the proximity of the hub to the South Downs a large emphasis is placed on Mountain Biking and The South Downs National Park, in conjunction with Cycle Seahaven are running successful 'Ride the Downs' days from the hub.

Another major user group is ESCC themselves who already run a successful hub in Eastbourne. The primary activities offered by ESCC are Bikeability Training for younger people and Wheels 4 All which provides speciality bikes for use by people with physical and special learning needs. Wheels 4 All bikes are used in the nearby Multi Use Play Area, which is flat and a safe space for this activity.

There are a range of other user groups and stakeholders who are keen to use the hub in the future, not, least a local health walk group and also other cycling groups and societies who have been engaged with at Stakeholder meetings.

### Development.

Currently the Hub consists of a solitary shipping container which is not big enough to store Wheels 4 All bikes as well as the bikes and equipment that are already in there. For that reason a second

shipping container is going to be placed opposite the first one and also clad in the same Sweet Chestnut boarding.

All user groups and stakeholders have stated that they would like a shelter under which they can meet, fix bikes or simply rest after a long walk or cycle and ESCC have agreed that they can provide some budget for this.


Talking with local builders and carpenters led to the conclusion that building a bespoke structure on the site would be simply too expensive so I have come to the conclusion that we would like to buy an off-the-shelf wooden pavilion which can be bought and delivered for a fraction of the cost of building one.


The pavilion will be built from wood, so still in keeping with the look and feel of the Café and will make an attractive area where walkers and cyclists can meet and sit before or after a ride or cycle.

Hello all Peacehaven Councillors

My name is and I am a resident of Peacehaven.

Over the past 10 years I have become more disabled. Since 2017 I have been unable to walk any distance. Consequently I have invested in a large mobility scooter.

I used to enjoy a walk along the undercliff with my friends and family but now find that I am unable to access the slopes although my scooter is more than able to manage the climb.

The accesses at the bottom of Malines Avenue and Steyning Avenue are not suitable or safe. The pedestrian entrance at the bottom of Malines Avenue is too tight to get through also denying me access to Howard Park. The Steyning Avenue access is over a kerb and too high.

I notice that the Mayor's plans include focus on the disabled.

I llok forward to hearing from my councillors as to gow disabled access to the above facilities will be improved.

### History

The last Council administration agreed that there should be a consultation with residents about how they would like to see the park managed in the future and any improvements or additions that could be made.

Emphasis was placed on personal contact with the residents living in Cairo Avenue and an event in the park where any users of the area could give their views; unfortunately this was never taken forward.

There are restrictions in the deeds regarding what can happen on the land and any plans would have to include the protection of the active badger sett at the north of the site and management of the rabbits that live there.

Peacehaven & Telscombe Access Group have already agreed to provide a sensory garden in the park.



# LA 325 ACQUISITION OF LAND IN HOWARD PEACE PARK WHICH IS IN UNKNOWN OWNERSHIP

Howard Title deed was transferred to Peacehaven Town Council on 26 July 2006

Title Number ESX296811.

Land maps of the area show two areas that are on land we maintain which are of unknown ownership.

### LA 326 PEACEHAVEN BOWLS CLUB Health & Safety - Parks Manager

We have received two letters from the bowls club indicating two incidents where bowlers have tripped over at the bowls green, both times the injuries were just bruising.

The Town manager and Parks officer had a meeting with Mr Giles from the Bowls Club on the 4<sup>th</sup> June 2019; they bought up several issues with regards to the surrounding pathways and car park which we are now looking into. There are a set of minutes in the office if councillors want to have a look, but the main items bought up were-

- The tarmac path way from Piddinghoe avenue into the park has deteriorated and a
  member tripped up and fell causing bruising (this area has been temporarily
  resurfaced), the path is also too narrow and is not DDA compliant as it is only
  900mm wide and should be a minimum of 1200mm wide- the Parks officer has
  arranged a site visit from Sussex driveways to obtain a quote for works needed and
  will draw up a specification, verbal report if quotes have arrived
- Fading of the disabled car parking markings and directional arrows, they also asked if two extra disabled spaces could be created on the south west of the car park- parks officer to investigate the costs, verbal report if quotes have arrived.
- Uneven slabs pathway around the bowling green, could this be changed to a tarmac surface - whilst the slabs are within tolerances, because of the age groups that use the facilities trips are more likely, parks officer to look at the cost involved, this could possibly be part of an application for CIL money in the future.

### FINANCIAL IMPLICATIONS

CIL or Big Park money could be allocated to any urgent works if required and the parks officer will bring estimates to the next meeting for all works.

### LA 327 FOOTBALL CLUB TEMPORARY CHANGING FACILITY

The football club have replaced a container type changing facility, which was rotten and falling apart, with one donated to them form Telscombe playing fields. This is a like for like temporary building so no planning permission was needed.

### LA 328 CREATING TWO EXTRA DISABLED SPACES IN THE BIG PARK CAR PARK

It has been requested that two extra disabled spaces in the south/ west corner of the car park near to their wooden gate



### FINANCIAL IMPLICATIONS

This can be included in the repainting that is required in the car park at little extra cost and can come from Peacehaven town Council CIL money.

### DECISION

To change two parking spaces to disabled spaces at the big park.

### LA 329 THE HUB BUILDING

### History

The building called the hub previously the sports park pavilion has been gradually deteriorating since it was built in the early 1980's. Our handyman Andy Pickton has compiled a list of works that are required to bring the building back into reasonable condition.

### Priority items

Roof bolts to stop leaks – one quote has been received but no other company has shown an interest in carrying out the works £925.00 + vat

Double glazed doors near kitchen not secure- awaiting quotes for new doors

Boilers replacement- currently awaiting quotes to apply for CIL funding but this may have to wait until the next CIL window.

### Jobs Andy Pickton can do in house

Guttering and pipe work repairs

Outside and inside paintwork

New Kitchen cupboards and work tops

Window locks

Replace blinds some cords broken

### Contractor jobs

Outside lights all broken- security lights

Referee shower no water pressure- will come under renewal of the boilers

Toilet refurbishment- all original fittings 40 years old

Replace bi-fold door glazing two panels- cracks and stone damage

### DECISION

To go ahead with replacing the roof bolts and seals at £925.00+vat (the price may change as the quote is from March, Parks officer to check this)



### LA 330 OVAL ACCESS GATE

It has been requested that we install a DDA compliant gate at the oval to allow access to the Community Allotment Garden area; this will allow less abled people to gain access to the area as well as make it easier for the volunteers to deliver supplies to the allotment.





For the groundstaff to install a wooden gate with a spring self-closing mechanism and latch would be £300.00.

To purchase and install a wooden gate at the Oval.


### Peacehaven Community Garden

Peacehaven Community Garden was set up in March 2017 by Peacehaven Town Council and local volunteers. It is located in a small secluded position at the south end of the Oval and is most easily accessed from Green Gate where there is limited parking. It is easier to arrive on foot or cycle than by car or take the No 14 bus to Brett's Field and walk through the park.

The initial setup was funded by Peacehaven Town Council which was used to provide a secure shed for tools, garden tools and some of the fruit trees. Veolia, Burley's and various seed companies have contributed seeds and materials. Many residents have contributed tools, plants and other materials.

Everyone is welcome no matter what your ability or experience although at present it is not accessible for wheel chair users, to visit the garden and learn to grow fresh fruit and vegetables. The garden is a haven for wildlife and follows organic growing practices. It is an outdoor classroom and is looked after by a team of volunteers.

Sessions are generally held on Saturday mornings from 10am for around 2 hours but you can visit at any time.



The garden grows a wide variety of vegetables, fruit and flowers. The central area is a wildflower meadow with grass paths to guide visitors around the wilder areas. As well as

soft fruit such as gooseberries, raspberries, strawberries and rhubarb there are tress including plums, cherries, apples, pears and damsons.

Initially there was great enthusiasm and plenty of volunteers and their children involved. However more recently this has become more difficult despite there being 248 members of the Peacehaven Community Garden Facebook group. Peacehaven Community School have also been involved at times with some of the students with learning disabilities. This activity has now moved to the school where they have their own garden and they are supported by one of our volunteers.





Water has always been a problem; we have several large water butts that collect water from the shelter but this is never enough and they need filling regularly which has been done occasionally by PTC grounds staff.

The garden is a **Peaceful Haven**, it has a huge potential to educate and improve the well-being of many people in the area. It can improve physical health and have positive impact on mental health. It is a haven for wildlife that can be studied. It has the potential to be used a Forest School and an outside classroom. It can address issues of loneliness and isolation. Allotments in the area are oversubscribed with waiting lists of many years and for many residents living in flats with no gardens it can be an outlet. Community gardens can take a long time to fulfil their expectations. There are well established community gardens in Seaford and Newhaven but these have taken decades to reach their current status.

We are often asked what happens to the produce. This is available to anyone who wants it although there is not much of it. The productive area of garden is of a similar size to an allotment. Donating fresh fruit and vegetables to a food bank is not realistic as they spoil quickly. The Newhaven Food Bank run by SCDA does not accept perishable food.

Community gardens contribute to a healthy lifestyle by:

- providing fresh, safe, affordable herbs, fruits and vegetables
- helping to relieve stress and increase sense of wellness
- getting people active, which improves overall physical health
- · providing social opportunities that build a sense of community and belonging
- giving people an opportunity to learn and share knowledge on gardening, nature, and cooking

Further developments that are being considered include:

- making the garden accessible by wheel chair users
- installing a composting toilet (the nearest public toilets are almost a mile away)
- improving the water collection and storage system
- improving the composting system

- encouraging inter-generational activities
- making better use of the space available e.g. yoga classes painting classes etc.
- referrals from GPs and other health professionals




### LA 331 CIL MONEY REPORT - Parks Officer


It was made clear that if the town has a neighbourhood plan in place it would be more likely to be successful.

### LA 332 ADDITIONAL DUAL WASTE BIN AT THE ORCHARD.

Residents have asked if an additional dual waste bin could be bought and installed on the north east corner of the orchard as people often leave bags of waste in this area, currently we have approximately 17 dual waste bins in the big park. The map below shows the current bins in red and the proposed bin in blue. We could relocate a bin from the skate park as there are 2 there, at a cost of £20 for cement and sundries.



### FINANCIAL IMPLICATIONS

To supply a wooden bin like the current bins in the big park £495.00



To supply a plastic alternative bin from £90.00



The cost for emptying the bin twice a week would be approximately £5.00 per week this includes time, fuel costs, paladin bin costs and black bags.

\*Note all our dual waste bins are emptied twice a week as a full bin bag of dog excrement can weigh above the 20 kg limit on lifting.

### DECISION

Councillors are asked to decide to buy and install or relocate an existing bin.

### 21 LA 334ROAD SURFACE - ROWE AVENUE/THE DELL

We have had residents complaining about the road surface from the A259 to the gate to the Dell as it is very uneven. The road is unadopted but in the past we have bought some loose stone and filled in the worst holes as we do have heavy lorry's using this part of the roadway when fairs and the circus use the Dell.

The works would involve employing a contractor to carry out the works.

### FINACIAL IMPLICATIONS

The cost for this works could come from CIL money or from revenue from the Dell hiring's
