7 members of the public were in attendance.

### 1. PH2098 CHAIR ANNOUNCEMENTS

The Chair opened the meeting at 19:30, welcomed everyone, reminded members of the importance of PTC's commitment to an environment of civility and respect, ran through the fire exit procedure, asked for phones to be switched off, announced that the meeting was being recorded, that a public question was restricted to 3 minutes maximum and standing orders were only to be suspended when absolutely necessary.

The following announcements were made:-

### 2. PH2099 PUBLIC QUESTIONS.

There were 3 public questioners.

The first questioner – The General Manager of Dorothy House, a sheltered housing scheme for vulnerable people of retirement age and older, complained the property had been flooded 12 times, including with human waste, inside and outside the property between 2005 to 2024 due to a broken East Sussex Highway's drainage pipe, and that the additional new housing had increased the frequency. The resident expressed that East Sussex Highways had installed flood doors in July 2023, and had said they would repair the pipe, which would involve removing part of the play park at Centenary Park, but this was now on hold due to withdrawn funding. The questioner added that the flooding had greatly increased their insurance and requested pressure be applied to East Sussex County Council to authorise East Sussex Highways to repair the broken pipe.

The Vice Chair suggested the resident wait for a response from ESCC, expressed this was a very serious issue and that ESCC Councillors should be contacted.

The Town Clerk confirmed that progressing the issue through ESCC councillors would be the best route.

The second member of public provided committee with reasons behind their planning application PH2111 PH LW/24/0595 21 Downs Walk, and expressed that neighbours' concerns had been addressed.

The third resident raised that a SpeedWatch presentation was to be held by the Community SpeedWatch Officer, Steve O'Connell, on 5<sup>th</sup> December at Telscombe Civic Centre, and the need for more SpeedWatch volunteers. The resident provided information on real-time-information bus signs, where ones along the south coast road would be replaced this week, and ones in North Peacehaven would be replaced shortly, but had no update about the promised sign at the bottom of Telscombe Cliffs Way.

The Town Clerk explained the background of the item, confirmed it was not related to item PH2055, explained how the steering group worked, expressed both PTC and Telscombe Town Council were part of the steering group, and was unsure why the report had not been noted.

There was debate as to whether noting the report meant noting the maps mentioned in the report. Cllr Gallagher expressed that maps were not part of this meeting's update and that only the appendices, which were not maps, were to be noted. Whereby Cllr Campbell emphasised the recommendation was to 'note the report', which meant noting the mentioned-maps, and expressed concern that noting the report meant noting the maps and would imply PTC endorsed them.

The design is incongruous with the area. The continuous building of out-of-character high-storey flats on the South side of the South Coast Road are blocking the light for neighbouring properties which are mainly bungalows and this is affecting the skyline on the South Coast Road

Southern water also have also noted drainage and sewerage concerns and Peacehaven Town Council's Planning & Highways Committee also share these concerns.

### 1. Background

On 8<sup>th</sup> October 2024 at Full Council under item C1278, it was agreed to look at the financial benefits of listing the monument and for the item to be deferred to this meeting. Since then:-

- The funding benefits of being listed has been followed up with Historic England, and will be brought to the next Committee meeting.
- A replacement bin (used) has been installed at the site (as per photo below) to replace the deteriorated dog bin.



• The old lectern frame has been removed, along with the remainder of the old beacon wood, as it was rotted through (photo below).



- The Town Clerk has confirmed that, based on a doctrine of precedent, in so much as PTC has previously spent money restoring and maintaining the monument and obelisks and has done so for around 60 years from what we can evidence, he is satisfied that we can continue to do so without undertaking any further due diligence.

- One comment from the TFG has been, to avoid damaging the structure of the monument\*, that no work should be done on this until after the next meeting.
- \* Along with 3 quotes for renovating the monument received in April / May 2024 (which ranged from around £15,000 £21,000 ex VAT), structural monument information from one of the companies was received (please see appendix A).

Thank you, Zoe.

As I suspected, the structure of the monument is ashlar masonry of some type – heavily covered with masonry paint.

You can see the joint lines on the attached image -especially at the head of the Romanesque arch above the water fountain bowls.

It is very likely Portland Stone under there, and we will make allowance in our proposal for the reinstatement of a protective coating, but of a modified limewash rather than modern paints. We will assume an amount of mortar repair to the substrate which will be treated as provisional. We note also the raised ground level, damaged and sometime missing paving and the lack of services.

We will allow to strip the paint off with a high-temperature low-pressure water cleaning machine, and conservation grade paint stripper. This will reduce any chemical use to the bare minimum.

Subject: Urban Grass Cutting 2025

Dear Peacehaven Town Council,

I am writing in relation to the urban grass cutting service for 2025. East Sussex County Council (ESCC) is continuing to offer the same options as last year and would be grateful if you could let us know which option your Council would like to choose for the 2025 season.

This year we have reviewed our verge database and have amended any discrepancies within our mapping where verges have been managed incorrectly in previous years. This means you may notice an increase in the figures outlined in the options below.

### **Options**

**Option 1 - Standard:** Two cuts over the course of a year to be carried out by ESCC at no cost to the Parish/Town Council. Urban grass will be managed for safety purposes only.

**Option 2 - Extra cuts:** Parish/Town Councils may fund an additional four cuts to be carried out by ESCC, totalling six cuts (two standard and four extra) over the course of the year. This would cost the Parish Council a total of £16,178.39 for the year.

**Option 3 - Self delivery:** Parish/Town Councils take on responsibility to deliver all urban grass cutting in their area. This must include a minimum of two cuts over the course of the year. ESCC will not carry out any urban grass cutting in the area. ESCC would pay the Parish Council the sum of £8,089.20 to cover the 2 cuts they would have been providing in other options.

It should be noted that any contractor employed must be suitably competent and qualified to work safely on the highway, evidence of which must be supplied to ESCC. We also request an agreement to be signed between ESCC and the Town Council if you opt to self-deliver. Further details are available in the attached document.

### **Cost Changes**

As stated in last year's option email we will be gradually increasing the cost of the grass cutting over the next 5 years to reflect the increased cost of the grass cutting service to the County Council. The below table states the cost increase over the next 4 years. The top line of the table states how much it costs ESCC to undertake the works, the middle line is what we will be charging local authorities per SQM and the bottom line is what we will be charging Peacehaven Town Council per cut for the next 4 years. Please note this is worst-case scenario where inflation runs at 5%.

Please note these figures are based on the forecast SQM area for your Town/Parish for 2025. These figures are subject to change once the maps have been finalised at the beginning of each year.

### **Agreement and Evidence Documents**

We request all who decide to self-deliver the Urban Grass Cut to sign an agreement.

The agreement outlines both East Sussex County Councils responsibilities and your own.

You will be asked to sign two copies and send the physical copies back to us. We then Seal both and send one copy back to you for your records.

The Agreement must be signed and sent back to us before the contractor commences work on the highway.

### Notes on employing a contractor

As noted below, we also request certain documentation to be provided from your contractor. We request this every year as certain documents should be updated each year, such as Risk Assessments and Methods Statements.

When employing a contractor to carry out verge cutting on the highway you must satisfy yourselves of their competence.

Any individual carrying out works on the highway (including grass verges) must comply with all relevant legislation including, but not limited to, the <u>Highways Act, 1980</u> and the <u>New Roads and Streetworks Act (NRSWA)</u>, 1991.

They must also be trained and competent as required by the <u>Safety at Streetworks and Roadworks Code of Practice</u>, 2013. This includes training in traffic management as well as the use of machinery.

Further information on Street Works qualifications.

In addition they must be able to provide copies of:

- Staff training and qualifications in traffic management including signing and quarding
- Staff training and qualifications in the safe use of machinery
- A formal contract with your Council
- Insurance certificates including a minimum of £10 million public liability insurance
- · A health and safety policy
- Risk assessments for carrying out verge cutting on the highway
- Method Statements for carrying out verge cutting on the highway

Copies of evidence **must** be sent to <u>contracts.managementgroup@eastsussex.gov.uk</u> **before** the contractor commences work on the highway.
