**DRAFT Minutes of the meeting of the Leisure & Amenities (L&A) Committee meeting held in the Anzac Room, Community House on Tuesday 13<sup>th</sup> January 2026 at 7:30pm.**

**Present:** Cllr Griffiths (Chair), Cllr Campbell, Cllr Gallagher, Cllr Fabry, Cllr Harman, Cllr Donovan.

**Officers:** Kevin Bray (Parks Officer), Zoe Polydorou (Meetings & Projects Officer).

There were no members of the public in attendance.

The Meetings and Projects Officer opened the meeting at 20:08 and in the absence of a Chair, asked for a proposal for a member to Chair the meeting.

Two proposals were made, and the initial proposal moved first.

It was proposed that Cllr Griffiths took the Chair.

3 members were in favour.

It was proposed that Cllr Donovan took the Chair

**Proposed by:** Cllr Gallagher                      **Seconded by:** Cllr Fabry  
3 members were in favour.

With equal voting numbers, the proposals were voted upon again, with the same results.

The decision was made with a coin toss, which resulted in Cllr Griffiths as Chair.

**1. LA 1071 CHAIR ANNOUNCEMENTS**

The Chair welcomed everyone, read out the Civility and Respect statement, went through the building fire procedures, asked that phones be put onto silent, informed everyone that the meeting was being recorded and reminded members of the process of a confidential item.

The Meetings and Projects Officer updated committee that the Howard Peace Park Phase 2 Consultation was live until 31<sup>st</sup> March 2026.

**2. LA 1072 PUBLIC QUESTIONS.**

There were no public questions.

**3. LA 1073 TO CONSIDER APOLOGIES FOR ABSENCE & SUBSTITUTIONS**

**4. LA 1074 TO RECEIVE DECLARATIONS OF INTEREST FROM COMMITTEE MEMBERS**

There were no declarations of interest.

**5. LA 1075 TO APPROVE AND SIGN THE MINUTES OF THE MEETING OF THE LEISURE AND AMENITIES COMMITTEE MEETING HELD ON TUESDAY 2<sup>nd</sup> DECEMBER 2025**

The resolution was **carried**.

**6. LA 1076 TO DECIDE ON SUNLEAF SAUNA IN CENTENARY PARK PROPOSAL**

Members discussed reasons for and against the sauna, including support through an increase in foot-fall, providing an income stream, and that it was easily moveable. Reasons against included concern over its security; the need to have sight of market research and a business plan; Centenary Park as an unsuitable location; the increase of parking and congestion; and the logistics of the water supplied by the café.

It was suggested that that the extra unit should be charged, other parks could be more suitable, and raised that there should be no liability to the Council.

The Parks Officer expressed a business plan was unnecessary to make a decision, and that the income could be around £100 per month.

It was proposed to support Sunleaf to take the idea forward so they can start their research and allow officers to progress the project with cost effective licences to be agreed by Council.

**15. LA 1085 TO DISCUSS AND AGREE HUB IMPROVEMENTS TO INFORM A HUB PHASE 2 CIL FUNDING APPLICATION**

Cllr Gallagher requested it be noted they were very impressed with the consultant who carried out the stakeholder engagement, and suggested they were asked to come in to feedback, and for a copy of the presentation and video. Cllr Donovan agreed it was an immersive consultation.

The Meetings and Projects officer expressed the importance of moving forward with the timeline, and outlined what was required for the CIL Expression of Interest application.

Members discussed progressing this item through the Community Buildings Working Group. Cllr Campbell clarified that the now-permanent Community Buildings Working Group had been formed on a temporary basis, and there being no opportunity for others to join. Several members expressed this phase was separate to phase 1 of the Hub project, the Parks Officer briefly clarified the current status of The Hub Phase 1, and Cllr Fabry requested focus returned to the agenda item.

It was proposed to take this report as Phase 2 to the Community Buildings Working Group, with the results taken to Council.

### Payment

The new tenancy agreements plus updated terms and conditions and accompanying letters were sent out in January, with payment and return of the signed documents due within 30 days.

We had 4 tenants relinquish their plots and have replaced these with 4 new tenants

On the 4<sup>th</sup> of March 2026 eleven warning letters were sent out for non-payment of the rent this gave the tenants 15 days to pay or be evicted, a verbal update on this will be given on this.

There were also ten warning letters sent regarding not returning the signed T&c's to us a verbal update on this will be given on this.

### Inspection

An inspection was carried out by the Parks Officer and Tom James (assistant) at the beginning of March, once on the site it was clear the weather had been so bad we could not have expected the plots to be worked during the start of the year, so we have rescheduled this for April.

## Update from the liaison Cllrs

Together with Peacehaven Horticulture Society Trustees the Hut is being opened in March and a base for Liaison Councillors established at The Hut.

The aim is to have greater mutually beneficial interaction between PTC, Liaison Councillors and PHS A further plan for 2026 will be agreed and communicated shortly.”

- Will maintain their designated plot to a standard congruent with the terms & conditions
- Must notify the Council as soon as practically able to of any considerations as to why the terms & conditions cannot be adhered to.
- Can raise any questions, problems, or concerns directly to the Leisure, Amenities, and Environment Committee during the public session.

#### 6. Enforcement

The Leisure, Amenities, and Environment Committee shall oversee the implementation and enforcement of this policy.

Where tenants are not meeting the agreed Terms & Conditions, Officers will notify the tenant by the means of enforcement letters, for which agreed pro-forma letters are available.

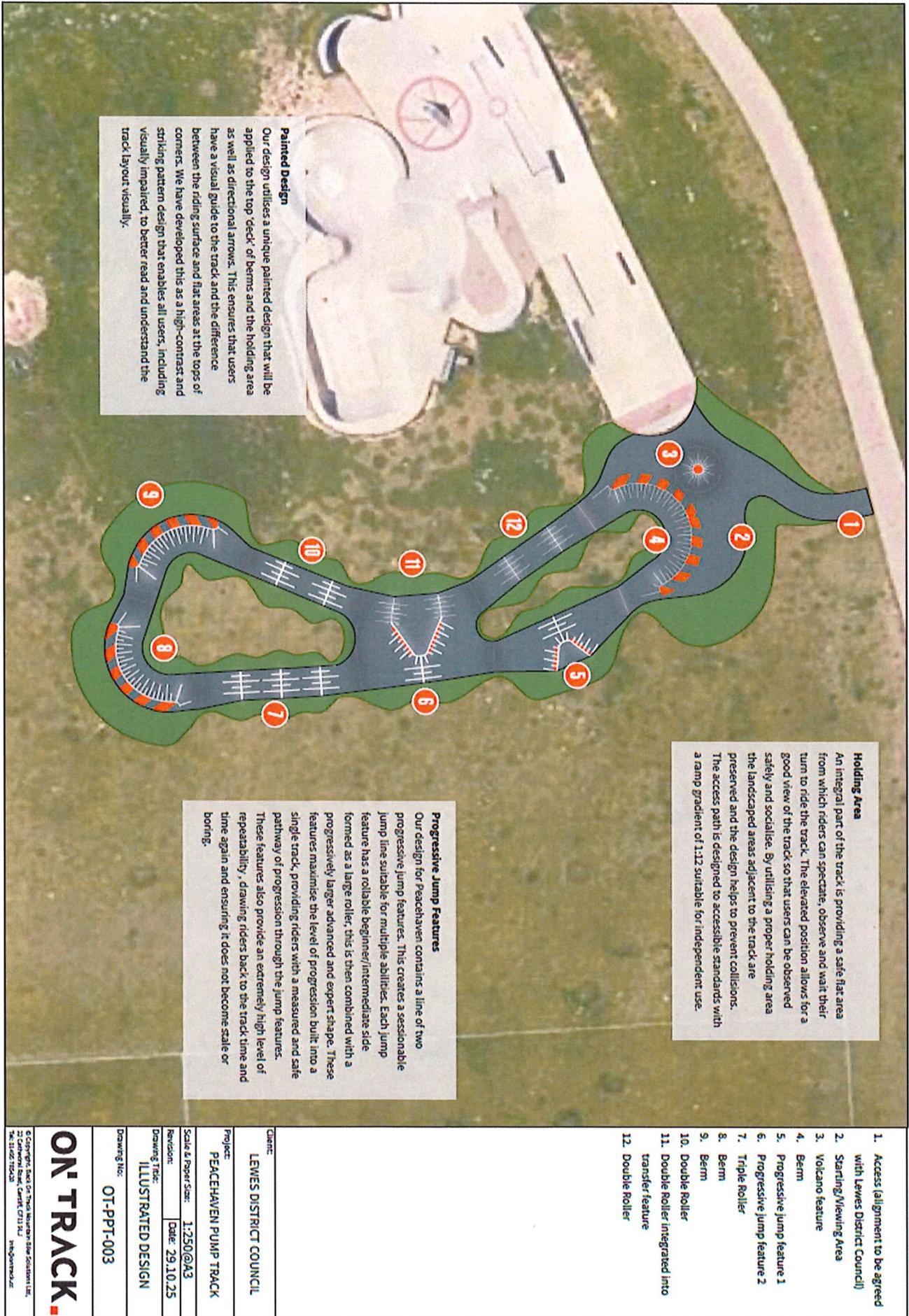

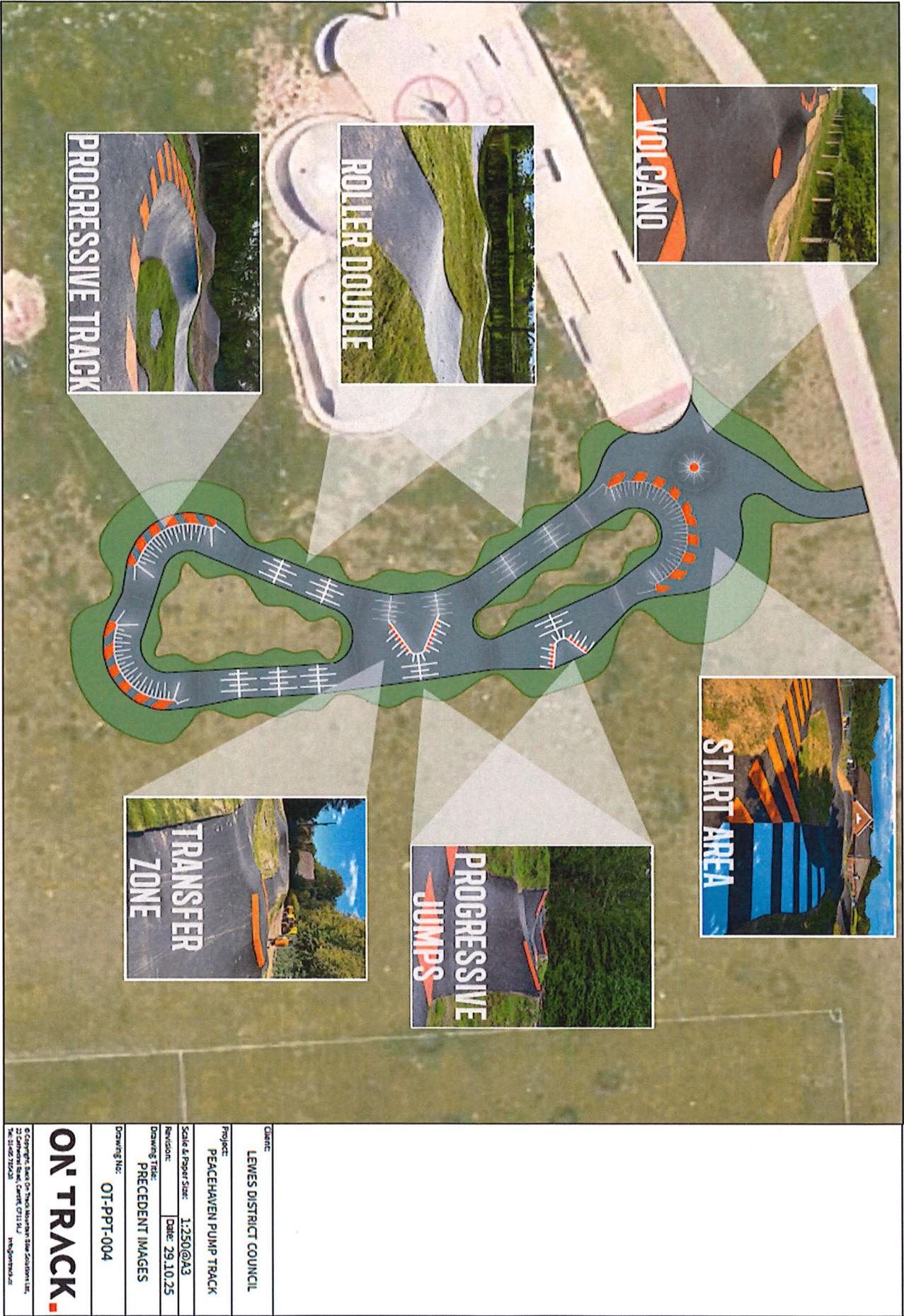
**Painted Design**  
 Our design utilises a unique painted design that will be applied to the top 'deck' or berms and the holding area as well as directional arrows. This ensures that users have a visual guide to the track and the difference between the riding surface and flat areas at the tops of corners. We have developed this as a high-contrast and striking pattern design that enables all users, including visually impaired, to better read and understand the track layout visually.

**Holding Area**  
 An integral part of the track is providing a safe flat area from which riders can spectate, observe and wait their turn to ride the track. The elevated position allows for a good view of the track so that users can be observed safely and socialise. By utilising a proper holding area the landscaped areas adjacent to the track are preserved and the design helps to prevent collisions. The access path is designed to accessible standards with a ramp gradient of 1:12 suitable for independent use.

**Progressive Jump Features**  
 Our design for Peachhaven contains a line of two progressive jump features. This creates a sessionable jump line suitable for multiple abilities. Each jump feature has a rollable beginner/intermediate side formed as a large roller, this is then combined with a progressively larger advanced and expert shape. These features maximise the level of progression built into a single track, providing riders with a measured and safe pathway of progression through the jump features. These features also provide an extremely high level of repeatability, drawing riders back to the track time and time again and ensuring it does not become stale or boring.

## 1. Background

In 2021 it was agreed to purchase a self-propelled chipper/ shredder for use by the groundstaff when cutting hedges and trees in the town. This decision was based on saving time, money, use of vehicles, etc taking the green waste to Ringmer on the flatbed truck and also significantly reducing the CO2 produced during the hedge cutting season.

The Machine has been a great success and no vehicle movements away from the town to dispose of green waste has occurred since its purchase. When the committee discussed the machine, it was agreed it was a high wear item and should be replaced every 5 years to avoid spending too much time and money on breakdowns and repairs etc as the machine got older.

There was an accident in February which resulted in the machine tipping onto its side whilst being transported, no member of staff was injured, but the machine's engine was damaged beyond reasonable repair as well as some other parts bent or broken, the total cost to replace the engine and repair the 4 ½ -year-old machine is £1588.50 inc vat.

The chipper will be 5 years old in September 2026, so the cost of a new chipper has to be considered as an option rather than replacing the engine on a machine that is to be replaced in the next 12 months. This is quoted at £9166.67+ vat

## 2. Options for Council

- a. To repair the machine as quoted and look to trade-in in 2027, you may get the money spent on the repair back when doing so.

**OR**

- b. To look at buying a new machine as quoted (this cost includes a 20% discount but not the £400 trade-in offered on the broken machine) this would have a 1-year warranty

### 3. Reason for recommendation

As the machine is due for planned replacement in 2026/27 it seemed good practice to ask the committee if spending the money repairing was deemed a good idea or to cut our losses and buy a new machine now, we could repair the machine, and it could suffer other issues due to its age and high wear usage.

### Budget

The finance officer states.

We have enough in the repair servicing budget in the current year to carry out the repair.

If we are looking to buy a replacement machine this could be funded from part big park 106, reserves and or the current budget for 2025/26.

## 1. Background

The expression of interest form to start our CIL bid for Epinay Park is being compiled and there is a question which needs to be answered” **How has development resulted in the need for this infrastructure?”** we have worded it as follows and wanted to make sure Councillors were happy with this.

*Peacehaven has had several large building projects in recent years, with the latest development of 40 homes was at 86 Pelham Rise which backs on to Epinay Park. In recent years, Meridian Community Primary School, which also backs onto Epinay Park has expanded their capacity, and regularly use the play park for ad hoc school events.*

*With the 40 new homes and the school having direct access to the park, this has increased the footfall significantly, which has meant the park is used more for play but also dog walking, this has impacted the playground area as with the lack of fencing this has meant the playground does not feel like a safe place for small children to play.*

*The current playground within Epinay Park is over 20 years old and does not have any fencing nor accessible play items with the equipment being at the end of its useable life. Peacehaven TC has had several different designs drawn up to show how the playground could be renewed to include accessible items with safety surfacing to cope with the increased usage as well as fencing to stop animal access to the playground.*
